Tuition and Fees Summer 2010

Camp Westmoreland is offered to children who have completed Kindergarten through 5th grade.

Camp is located at WCC's Westbrook Campus only.

Students bring a bag lunch from home each day.

Enrollment is offered for 2 week or 1 week sessions. *Priority is given to those enrolling for a full 2 week session.

In order to attend camp during session 5, students must be enrolled in at least one other session.

Level 3 - \$95,000 and Up

Level 2 - \$60,001 - \$94,999

Level 1 - \$60,000 and Below (There is scholarship assistance for those at this income level)

Families requesting Levels 2 or 1 tuition must submit a copy of their most recent Federal Tax Return.
